Revised times for ZAHAV system settlement windows

In the ZAHAV system, each payment system that sends multiparty payment orders has a defined settlement window set by system rules. According to these rules, a multiparty payment order must be sent 15 minutes before the window opens and wait in the system. However, following a system upgrade on July 10, 2022, orders in the new ZAHAV system are settled immediately upon entry within the defined time range. To maintain the timing of multiparty payment orders, the opening times for all settlement windows have been moved forward by 15 minutes, while the closing times remain unchanged.

In parallel with the ZAHAV system upgrade, an additional change is expected with the addition of clearinghouses operated by SHVA. With these new clearinghouses, payment card services, and ATM switching services entering the ZAHAV system, separate settlement windows will be established for them. The clearinghouses are expected to join the ZAHAV system in April 2023.
